Course aims Studying the concept, subject and importance of vicimiology as a science of crime victims, presentation of manners to assist victims of crime, as well as the manner of prevention from victimization.			
Course outcome Training of students for a successful understanding and recognition of the problem with which they deal with victimology, as well as the practical application of acquired knowledge in identifying and assisting victims of crime. At the same time, students gain knowledge of preventive activities and the sphere of victimization.			
Course content <i>Theory classes</i> The concept and definition of victimology, Basic determinants in victimology, Typology of Benjamin Medelson, Authenticity of justice and compensation of victims, Criminogenic aspect of victims, Connection of victimology with other scientific disciplines, Victimological disposition, Victim's relation to crime, Violent crime and victims, Victims and perpetrators of murder, Impact of organizational behavior, Alcoholism and murder, Victimological dimension of murder, Victims of act of infanticide, Victims of suicide, Psychological aspect of suicide, Victims of prostitution and trafficking of slaves, Victims of sexual delict, Victims of traffic delict. <i>Practice classes</i> Dissemination of the acquired knowledge and analysis of significant theoretical and practical problems, visits to institutions dealing with victims (Center for Continual Work, Safe Houses, KC Vojvodina, Protector of Citizens, etc.).

Teaching methods Teaching takes place through lectures and exercises. During lectures and interactive work, students acquire theoretical knowledge of victimology. Exercises are auditory and practical, students are about to solve tasks from individual chapters, provide additional explanations, and, for example, elaborate individual areas of theoretical instruction. The accent is placed on visits to the institutions dealing with the protection of victims and getting acquainted with the scope of their activities. Knowledge testing takes place through colloquium and seminar work. The condition for the final exam is that a student passes a colloquium, presents a seminar paper and successfully implements the exercises. The final exam consists of an oral exam.
