# Course aims

To familiarize students with the basic rules and principles that make up the modern international system...

#### **Course outcomes**

The outcome of the course is that students: understand the origin, structure and essence of international relations; master the basic legal concepts of international law, as well as their elements and types; have the capacity to pursue legal reasoning and argumentative debate on legal issues; adopts basic legal knowledge of the application of international law in real social relations, master the art of interpreting international legal norms, and also understands the basic principles of international contract law and rules on the settlement of disputes in international relations.

Introduction to the subject; 1. Sources of international law; 2. Entities of international law; 3. State; 4. Non-territorial entities with elements of subjectivity-existing or at the stage of creation; 5. Cases sui generis; 6. Recognition of states and governments; 7. Basic rights and obligations of states; 8. State jurisdiction in international law; 9. State responsibility; 10. Succession of states, state borders and ways of acquiring state territory; 11. Rules of international contract law; 12. International organizations; 13. International War and Humanitarian Law; 14. Crimes against humanity and international law; 15. International Court of Justice.

## **Teaching methods**
